Introduction: Calnex Solutions Ltd is committed to protecting and respecting your privacy and we comply with **General Data Protection Regulation**. Data is collected and held for both existing customers and for leads, potential new customers. Both of these categories of customers are covered by this policy.

Why do we hold your Information?

- **For existing customers,** we hold information that is required for us to support you in the use of our products and provide you with information about future product development and solutions.
- **For potential new customers (leads),** we will collect information so that we can contact you with the purpose of marketing our products and solutions to your company.
- **For potential employees,** we collect information that enables us to connect with you throughout the recruitment process and to assess your match to the applied for position.

What Data is collected and held?

- **Contact details:** name, email, telephone; so we can contact you.

- **Company name:** for contact purposes and to assess the fit of our products and solutions to your business.
- **CV (potential employees only):** to assess your match to vacant positions.

Marketing: Data is only collected for the purposes of marketing our own products and supporting technology papers/materials.

- You have the right to opt-out of receiving any future marketing material.

Disclosure of your Information: your data may be passed onto our business partners in your region for the purposes of marketing and selling Calnex products, or for providing support to existing customers. Your data will never be passed onto third parties not directly associated with Calnex's business. The personal data of potential employees is not shared with any third parties.

Retention of Data:

- **For customers** - we will continue to hold your information for the duration of the life of your product.
- **For leads** – we will continue to hold your information and provide you with relevant marketing material until you Opt-out.
- **For potential employees** – if you agree, we will continue to hold your data to match your skills and experience to future opportunities at Calnex.
